1. Please preregister by US Mail. Registration is on a first-come first-serve basis. Class size is limited by CTS policy to seventy-five (75) licensees per class. A confirmation will be sent via e-mail. Please insure that your e-mail address appears legibly on your Registration Form. Those registrants that do not have an e-mail address will receive confirmation by telephone.

2. CTS policy requires each attendee to have in their possession during the Update Class either a 2017 NEC* book or a nationally published book of major changes to the 2017 edition of the NEC*.

3. CTS policy requires each attendee to have their current electrical license and personal photo-identification at the time of class sign-in to gain admission. **Class sign-in will begin one-half hour prior to the start of each session.**

4. The Certificate(s) required for your license renewal will be issued at the completion of each class or each group of classes. There may be a ten-dollar (\$10.) fee per class for issuance of a duplicate certificate at any later date.

5. Cancellations and Refund Policy.

A. Requests received in writing, faxed, or e-mailed more than two (2) week prior to the class date attendee initially registered into have the following options:

1. You may take the same class within any semester (spring or fall) provided there is room available on the alternate date; or
2. You may request a refund.

B. Requests received in writing, faxed, or e-mailed two (2) weeks or less prior to the class date attendee initially registered into will ONLY be given the option of being rescheduled where there is a vacancy:

C. Transfer requests are final. There is no refund of tuition or alternate class given if an attendee does not notify us and/or does not show-up for class.
D. Refunds are as follows: If the entire program was purchased for \$150, each Update part (A or B) is valued at \$60. If Parts A or B were purchased separately, each part is valued at \$70.

E. Classes are subject to cancellation by Construction Training Service if preregistration falls below our minimum required attendance. **Cancellations by CTS will receive a full refund.**
