- 1. Choose a convenient location and date.

- **3.** Complete the form; Mail, eMail, or Fax completed form to **CCedu** (see below). Payment made with registration by US Mail receives first priority. Registration made via eMail or Fax is due on or by the day of class "at-the-door". Please use money order, or check payable to **Brian Mitchell.** "**At-the-Door" please use cash or money order.**

Important Attendee Information

- 1. Construction Code Education (CCedu) is an approved CT Electrical Work Examining Board (EWEB) Provider; Principal Instructor is Brian Mitchell. *This course meets the minimum requirements as set forth by the Commissioner.*
- 2. Please preregister by Mail, eMail, or Fax. Registration is on a first-come-and-paid, first-serve basis. Class size is limited to fifty (50) attendees per class. Payment by check or money order will be due with registration or by cash, or money order no later than the day of class "at-the-door", thank you. We do not accept credit cards! Paid registrants will be sent a confirmation via e-mail. Please insure that your e-mail address appears legibly on your Registration Form. Registrants that do not have an e-mail address will receive a confirmation by telephone.
- **3. EWEB** policy requires each attendee to bring and have in their possession during the Program a 2014 NEC* code book and a calculator. We do not supply these. We have the Stallcup's 2014 NEC* Major Change's books available for \$85.00 each, tax included. E-mail us to reserve a copy!
- **4. EWEB** policy requires each attendee to have their current electrical license and personal photo-identification at the time of Program sign-in to gain admission to the Program. **Program sign-in will begin one-half hour prior to the start of each session.**
- 5. The completion Certificate(s) required for your license renewal records will be issued only at the completion and conclusion of the entire class.

Cancellation, Transfer, and Refund Policy

- 1. Requests received by mail, fax, phone, or email, two (2) weeks prior to the class date attendee initially registered into have the following options:
 - **A.** You may take the same Program on a different date provided there is availability on the alternate date; or,
 - **B.** You may request a refund, if paid in advance.
- 2. Requests received by mail, fax, phone, or email less than two (2) weeks prior to the class date attendee initially registered into will ONLY be given the option of being rescheduled where there is availability.
